#### **BACKGROUND INFORMATION**

Per the *Bylaws of the Board of Regents*, the Board sets its schedule of regular meetings for the ensuing year at the annual meeting. Regular meetings of the Board shall be held in accordance with the schedule of meetings approved at the annual meeting. The Board may vote to change the date of any regular meeting. Notice of regular meetings shall be sent via electronic communication 10 calendar days prior to the meeting.



### OFFICE OF THE BOARD OF REGENTS 2023-24 Board Meeting Schedule

The regular meeting schedule of the Board of Regents is set in accordance with the *Bylaws of the Board of Regents* and Board of Regents Policy: *Board Operations and Agenda Guidelines*, Section V, Subd. 1:

The Annual Meeting of the Board is held on the second Friday in June, unless otherwise determined by Board *Bylaws*. At the Annual Meeting a schedule is approved for regular meetings, which are usually held on the second Friday and preceding Thursday of each month in February, March, May, June, July, September, October, and December.

Other meetings are scheduled as needed and may include work sessions, open forums, and public hearings. Retreats, typically held annually in the summer, are opportunities for the Board to plan, assess its performance, develop priorities for the year, and/or to consider a particular topic.
