# **PURPOSE & KEY POINTS**

The purpose of this item is to introduce Charles Nies, the new chancellor of the University of Minnesota Duluth (UMD).

Nies comes to UMD with over 25 years of experience in higher education. Prior to his work at University of California, Merced, he served as an assistant dean of an interdisciplinary school at Miami University in Ohio and a program director for a minor in leadership studies at Washington State University. As an instructor, he taught undergraduate and graduate courses in leadership theory, organizational theory, and student development.

Nies holds two degrees from Washington State University—a doctorate in education administration and leadership and a master's in counseling psychology. He received his bachelor's degree in psychology from the University of St. Thomas in St. Paul, Minnesota.

## **BACKGROUND INFORMATION**

As University of Minnesota Duluth Chancellor, Charles Nies is responsible for an annual operating budget of approximately \$299 million, and has general administrative authority over, and accountability for, campus affairs. Nies will articulate a vision for the campus, build support for that vision, propose priorities to the campus community, develop policies and manage financial resources, recommend faculty for tenure and promotion to the Board, and appoint and review performance of key administrative officers. Nies will also lead the advancement of UMD's strategic priorities.

#### **RESOLUTION RELATED TO PAUSE IN ADMINISTRATIVE HIRING PROCESS**

Regent Mayeron presented for review and action a resolution related to pause in administrative hiring process, as detailed in the docket.

A motion was made and seconded, and the Board voted 10-1 to approve the resolution related to pause in administrative hiring process, as follows. Regent Gulley voted no.

WHEREAS, on June 10, 2024, Interim President Jeff Ettinger paused the hiring process for the position of Director, Center for Holocaust and Genocide Studies within the College of Liberal Arts on the Twin Cities campus; and

WHEREAS, Interim President Ettinger's rationale for this decision was to ensure adequate participation of community partners in the search process, consistent with past practice for this role; and

WHEREAS, the pause was narrowly focused on the administrative appointment as a center director; and

WHEREAS, on June 26, 2024, the Faculty Senate convened a special meeting and approved votes of no confidence in the leadership of Interim President Ettinger and Executive Vice President and Provost Rachel Croson for their "unprecedented interventions into faculty hiring processes"; and

WHEREAS, Board of Regents Chair Janie Mayeron and Vice Chairs Doug Huebsch and Mike Kenyanya issued a statement as individuals expressing support for the Interim President's decision and confidence in his leadership and that of Provost Croson.

NOW, THEREFORE, BE IT RESOLVED that the Board of Regents endorses the statement made by the Board Chair and Vice Chairs, as follows:

We are aligned in our support for Interim President Jeff Ettinger's decision to pause the administrative hiring process for the director of the Center for Holocaust and Genocide Studies. He and Executive Vice President and Provost Rachel Croson have served the University of Minnesota exceptionally well throughout their tenures, especially in the face of multiple daunting challenges. We stand by and honor the principles of academic freedom while also recognizing that, when it comes to administrative leadership positions, the input and support of the community is vital.

#### RESOLUTION RELATED TO EXPANDED ALCOHOLIC BEVERAGE SALES AT HUNTINGTON BANK STADIUM, WILLIAMS ARENA/MATURI PAVILION, AND 3M ARENA AT MARIUCCI, TWIN CITIES CAMPUS

Regent Mayeron invited Mark Coyle, Director of Intercollegiate Athletics, Twin Cities campus, and Jon Steadland, Senior Advisor to the President, Office of the President, to present for action a resolution related to alcoholic beverage sales in Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci, as detailed in the docket.

A motion was made and seconded, and the Board voted unanimously to approve the resolution related to expanded alcoholic beverage sales at Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci, Twin Cities campus, as follows:

WHEREAS, the University of Minnesota (University) has important policy and educational interests in controlling the consumption, use, and sale of alcoholic beverages on its campuses; and

WHEREAS, Board of Regents policy prohibits the sale of alcoholic beverages on University property except when authorized by license, approved by the Board of Regents (Board), and sold and served in accordance with applicable law; and

WHEREAS, Minnesota Statutes Section 340A.404 authorizes the Board to hold liquor licenses for events at Northrop, Huntington Bank Stadium, and at no more than seven other locations within the boundaries of the University; and

WHEREAS, the Board currently holds liquor licenses for Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci; and

WHEREAS, the existing liquor licenses permit the sale of spirits in addition to beer and wine although only beer and wine are currently sold and served in these facilities; and

WHEREAS, selling alcohol in stands, or hawking, at Huntington Bank Stadium was restricted in 2014 but allowable under policy.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Regents, exercising its constitutional authority to govern and manage University property and facilities and consistent with Board of Regents Policy: Alcoholic Beverages, authorizes the sale of spirits at Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci during intercollegiate athletic events in specifically designated locations as determined by the administration. During events other than intercollegiate athletic events held at these facilities, alcoholic beverages may be sold and served in accordance with the University's state-granted licenses.

BE IT FURTHER RESOLVED, that the sale of spirits and alcohol service of those spirits will be introduced in a phased manner as follows:

• 2024–25 competition seasons: ready-to-drink canned and batched cocktails in concessions and premium areas at Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci;

- 2025–26 competition seasons: full-service bars in premium areas and bottle service in suites at Huntington Bank Stadium, Williams Arena/Maturi Pavilion, and 3M Arena at Mariucci; and
- 2026–27 competition seasons: hawking beer, wine, and ready-to-drink canned and batched cocktails in stands at Huntington Bank Stadium except for designated student sections.

BE IT FURTHER RESOLVED that the Board delegates to the President the authority to implement the amended policies and rules when it is permissible under law and U.S. Department of Education policy to do so and report to the Board when the amended policies and rules are implemented.

BE IT FURTHER RESOLVED that the Board delegates to the President the authority to cease (or restart if already ceased) implementation of these policies and rules should legal circumstances change and report to the Board any change to implementation.

## **RESOLUTION RELATED TO REQUESTS FOR DIVESTMENT OF CONSOLIDATED ENDOWMENT FUND HOLDINGS**

Regent Mayeron presented for action a resolution related to requests for divestment of consolidated endowment fund holdings, as detailed in the docket.

A motion was made and seconded to approve the resolution related to requests for divestment of consolidated endowment fund holdings, as follows:

WHEREAS, the Board of Regents (Board) has established policies that govern the investment and use of the University of Minnesota's (University) Consolidated Endowment Fund (Endowment); and

WHEREAS, the University seeks to maximize Endowment investment returns within the parameters set by Board policy to support the University's mission and advance the goals of current and future systemwide strategic plans, such as affordable tuition, groundbreaking research, and market competitive compensation; and

WHEREAS, Board of Regents Policy: Endowment Fund currently states that the "University shall integrate environmental, social, and governance principles in its investment decisions, consistent with the University's mission and values"; and

WHEREAS, there have been requests to divest of certain investments related to Israel and other specific Endowment holdings based on social and political matters and events; and

WHEREAS, the State of Minnesota has previously expressed its policy stance regarding discrimination against Israel through the enactment of Minnesota Statutes §16C.053, which prohibits state agencies from contracting with vendors who discriminate against Israel; and

WHEREAS, the Board engaged in a work session that reviewed current and past Endowment investment practices, the evolution of Board and administrative actions in this area, the effect of divestments on events and political matters, and the impact of divestments on the Endowment; and

WHEREAS, the Board and administration have engaged with a diverse array of stakeholders, including students, faculty, staff, alumni, community members, and legislators, and the Board acknowledges and respects the wide range of deeply held viewpoints regarding requests for divestment.

NOW, THEREFORE, BE IT RESOLVED that the Board, in exercising its fiduciary duty over the Endowment, adopts a position of neutrality with respect to the Endowment and directs the President to continue to base investment decisions on financial criteria as defined by Board policy. Given that position, the Board declines the request to divest of certain investments related to Israel.

BE IT FURTHER RESOLVED that the Board recognizes that divestment may be appropriate in rare circumstances and directs the President to develop a process for the submission of those requests for divestment, which shall include the evaluation of the request and, if determined by the President, a recommendation to the Board regarding the request. The following provisions shall be included as part of the process developed by the President:

- Requests for divestment must show how the investment is fundamentally incompatible with the University's core mission and values;
- Requests for divestment must demonstrate that there is a broad consensus regarding the request within the University community (e.g. students, faculty, staff, and alumni) as well as, where applicable, the State of Minnesota, the United States, and respected domestic and international organizations;
- The process to evaluate a request for divestment shall also take into consideration the potential impact on the social and political matters and events that the request is designed to address; and
- The process to evaluate a request shall also consider the financial and operational impact to the Endowment should divestment be implemented.

BE IT FURTHER RESOLVED that, for the avoidance of doubt, the Board's adoption of a position of neutrality with respect to the Endowment neither supersedes nor nullifies any prior Board or administrative actions with respect to divestments, including, but not limited to, the University's decision to divest holdings related to Sudan and the University's commitment to phased divestment of fossil fuels.

BE IT FURTHER RESOLVED that, for the avoidance of doubt, the Board's position of neutrality with respect to the Endowment shall be consistent with the integration of environmental, social, and governance (ESG) principles as required by Board of Regents Policy: *Endowment Fund* since the integration of ESG principles is intended to further enlighten and strengthen the investment decision-making process by providing a more comprehensive view of financial risks and opportunities.

Regent Gulley moved to amend the resolution, as follows:

- To strike out the following: NOW, THEREFORE, BE IT RESOLVED that the Board, in exercising its fiduciary duty over the Endowment, adopts a position of neutrality with respect to the Endowment and directs the President to continue to base investment decisions on financial criteria as defined by Board policy. Given that position, the Board declines the request to divest of certain investments related to Israel.
- To strike out and insert the following: Requests for divestment must demonstrate that there is a broad consensus support regarding the request within the University community (e.g. students, faculty, staff, and alumni) as well as, where applicable, the State of Minnesota, the United States, and respected domestic and international organizations;
- To strike out the following: BE IT FURTHER RESOLVED that, for the avoidance of doubt, the Board's adoption of a position of neutrality with respect to the Endowment neither supersedes nor nullifies any prior Board or administrative actions with respect to divestments, including, but not limited to, the University's decision to divest holdings related to Sudan and the University's commitment to phased divestment of fossil fuels.
- To strike out the following: BE IT FURTHER RESOLVED that, for the avoidance of doubt, the Board's position of neutrality with respect to the Endowment shall be consistent with the integration of environmental, social, and governance (ESG) principles as required by Board of Regents Policy: Endowment Fund since the integration of ESG principles is intended to further enlighten and strengthen the investment decision-making process by providing a more comprehensive view of financial risks and opportunities.

Mayeron called for a second. There was no second and the amendment was not considered.

Mayeron directed that a roll call vote be taken on the resolution related to requests for divestment of consolidated endowment fund holdings. The vote was as follows:



#### **PURPOSE & KEY POINTS**

The purpose of this item is to provide the annual report on fundraising and the impact of private giving across the University.

In FY 2024, the University of Minnesota Foundation (UMF) raised \$392 million in private gifts to the University. This includes 166,404 gifts received from 91,561 donors, of which 40 percent were alumni. Of the \$392 million, \$229 million (58 percent) was in the form of cash and pledges, \$160 million (41 percent) came from future (estate and deferred) commitments, and \$3 million (1 percent) represents property and in-kind gifts. FY24 giving supported a number of different areas at the University, including \$151 million (38percent) for program support, \$114 million (29percent) for student support, \$42 million (11percent) for research, \$34 million (9percent) for faculty and staff support, \$29 million (7percent) for capital improvement, and \$22 million (6percent) for outreach and community engagement. Distributions for University purposes reached a record level of \$284 million in FY24, an 8 percent increase from the prior year.

FY24 was the fourth year of the UMF's current strategic plan, which is guided by four imperatives:

- 1. Private Investment Transform the future through philanthropy and private investment
- 2. Engagement Connect current and future donors to causes that inspire them in ways they prefer to engage
- 3. Workplace Be a destination workplace where talented people feel a sense of belonging and build fulfilling careers
- 4. Operations Operate and innovate with a drive toward efficiency and excellence

These imperatives directly support the University's MPact 2025 Systemwide Strategic Plan (MPact 2025). UMF's fundraising focus is around two key initiatives supporting the strategic plan – *Learners to Leaders: Drive for University of Minnesota Students* and *Innovators and Educators: Drive for University of Minnesota Faculty*.

In addition, UMF is pursuing opportunities to increase private investment in each of the five MPact 2025 commitments, goals, and actions around Student Success; Discovery, Innovation, and Impact; MNtersections; Community and Belonging; and Fiscal Stewardship.

UMF provides a number of centralized services which support efficiency at the University, including central expertise in gift planning, prospect development, fund administration, events, regional and international development, gift receipting, database management and security, as well as many other functions.

#### **BACKGROUND INFORMATION**

UMF is a nonprofit organization that exists to benefit the University. It was established in 1962 with a mission to connect passion with possibility, inspire generosity, and support greatness at the University. UMF is governed by a 43-member Board of Trustees, with one-quarter of Trustees nominated by the Board of Regents. In addition, Regents Davenport, Huebsch, and R. Johnson and President Cunningham are current UMF Trustees, and Regent Farnsworth serves on UMF's Audit Committee.







#### **PURPOSE & KEY POINTS**

The purpose of this item is to discuss the University's current Indirect Cost Recovery Rate (ICR) and implications for future changes. Key points include:

- An overview of ICR (sometimes called "F&A rate") and how it is defined by federal regulations, how ICR is calculated and charged, and how it impacts sponsored projects revenue
- The University's ICR on sponsored projects is declining due to lack of investment in major research facilities
- Lower ICR rate would have both reputational and financial implications, including:
  - lower recovery of facilities and administrative costs than would otherwise be the case, reducing needed revenue for the University
  - potential drop in NSF's Higher Education Research and Development (HERD) rankings compared to peers who are investing and have better F&A recovery
- Without facilities investment, the University's F&A rate could potentially fall from 54 percent to 42 percent within four years, assuming a 5 percent growth in research activity each year







# To Grow (or Even Maintain), We Must BUILD



- UMN lost 1% in recent indirect cost rate negotiation (from 55% to 54%) because we are not growing our research facilities as fast as our research funding
  - UMN's estimated F&A under-recovery from FY25-FY28 will be \$8.4M
- Continuous drop <u>will</u> substantially reduce the growth in indirect cost recovery (ICR) readily available to commit to administrative, facility, or other costs as explained earlier
- This trend, if unaddressed, will also compound, resulting in our research indirect cost rate dropping substantially in our next negotiation
- Long term, a lack of new facility construction could result in the University dropping from the top tier of research universities (NSF HERD)



### Violent Crime Rate Comparison Per 100,000 people








